AmazonSmile is tracking down, possibly due to excessive COVID spending the year before. \$1000 Investors Bank grant payment was received; this can be budgeted for future MB mobile speakers. Awaiting Costco and Whole Foods grant responses.
3. Membership, **Diana:** 1 duplicate membership was added due to jazz band parent letter; this will be added to next year's roster. 59 paid-up current members.
4. Fundraising, **Shivani, Priyanka:** April 29th will be Anthony Coal Fired fundraiser, with 20% return on purchases. New: 20 family members must presign on ACF donor-dedicated website (28 have) to proceed with fundraiser. Future ice cream shop fundraiser and Blaze Pizza, possibly in May and/or June.
